



AGREEMENT FOR RENT-A-BIN SERVICE

1. Customer agrees to the following charges and will pay for delivery and disposal upon delivery of Rent-A-Bin.

BIN SIZE _____ DELIVERY CHARGE _____ DISPOSAL CHARGE _____

2. Bin rent is calculated at \$1.00 per day for weekdays only, beginning after the first week (7 days) which is rent free. Monthly rent is \$20.

3. Considerations for loading:

- A. All materials must be loaded evenly, AT OR BELOW TOP of bin with no overhanging items. Lids must close.
- B. No concrete, sod, dirt, rocks, bricks, composition roofing or heavy metal objects.
- C. No hazardous materials or liquid waste accepted, including paint, solvents and medical waste.
- D. Materials that might stick to inside of bin (esp: mortar, caulking, etc.) must be bagged.
- E. Tires cannot go in bin. Please set beside bin and call for special pick-up.
- F. No computer components accepted.

4. Site Considerations:

- A. Bins must be placed on level, smooth, hard surfaces with clear access for truck to pull straight in.
- B. Bins must be located away from overhead power and other lines.
- C. Place wood under bin wheels and stands if risk of damage to surface.
- D. Street permits from the City of Bend are required for any street placement, along with proof of insurance. City of Bend: 388-5580. This is the responsibility of the customer.

5. Do not attempt to move bins without wheels. This includes any attempts with backhoes, forklifts or tractors. Excessive bin damage will be charged back to customer on a time and materials basis. Call if bin needs to be relocated. Standby and relocation charge at \$_____ per hour.

6. It is the responsibility of the customer to call when the bin needs to be emptied. Please call for available service days.

7. All Rent-A-Bin service is performed on a C.O.D. basis unless other arrangements are made prior to service.

Customer will indemnify and hold BEND GARBAGE & RECYCLING, INC. harmless from any and all liability of any kind resulting from the use by the customer and said container and from the placement of said container at the stated address. The customer assumes liability for damages to public or private property, hard surface road or driveways which might occur during the loading or unloading of the container. Customer also agrees to pay any expense incurred by BEND GARBAGE & RECYCLING to enforce this agreement such as court, collections, and attorney fees.
